INSURANCE CONTRACT OF PERSONAL ACCIDENTS AND CIVIL RESPONSIBILITY FOR FEDERATED SPORTSMEN

RENEWAL OF THE POLICY

We inform you of the **renewal of the insurance policy for federated** people attached to the sports license and subscribed with the REALE Seguros company. This insurance covers, both the accidents of the federated suffered due to the practice of sports - in the terms provided by Royal Decree 849/1993, of June 4, which determines the minimum benefits of Compulsory Insurance Deportivo- as the civil liability that said federations also cause due to sports practice.

We attach a copy of the policy for your knowledge and that of all the federated, **asking them to proceed to give the greatest possible dissemination and to place it on their notice boards.**

COVERINGS

The INSURED are all federated athletes (amateurs / professionals / professors) with valid license of the RFEG, being specifically excluded the players with temporary license.

In addition, the Basque Golf Federation for its federated, has contracted a specific policy (No. 1020800000585/21) with the same coverage and guarantees as the RFEG.

The subscribed policy covers:

1. The **ACCIDENTS** suffered by the federated due to the **SPORTS PRACTICE IN A FEDERATED CLUB / FIELD**. **Accidents (personal physical injuries) suffered by the federated drivers of a golf buggy are covered**, in the terms provided by Royal Decree 849/1993, of June 4. This coverage **does not include the civil responsibility of the federated driver of a golf buggy for the damages caused (material or personal to third parties) due to the driving of said vehicle.**
2. **CIVIL RESPONSIBILITY** (damage caused by the federation, both materially and to third parties) in **ANY PLACE OF THE WORLD** in its capacity as a golf player (**except the one derived as driver of a golf buggy**), within the economic limits subscribed, the payment of the pecuniary indemnities that could be civilly liable for bodily or material damages, as well as for the economic damages derived from them to third parties. There will be third parties for the purposes of this coverage, the persons who, with respect to the

deceased, are spouses or blood relatives or related, up to the second degree, or employees in the development of the functions of their duties.

BUGGIES

We remind **all Clubs / Golf Courses and federated** sports facilities that **CIVIL LIABILITY** caused by the conduct / use of **GOLF BUGGIES IS NOT INCLUDED IN THIS POLICY**, which is why we are **RECOMENDING** that those who own them, in renting or leasing, **proceed to sign an INSURANCE POLICY** that covers the responsibility that this use / use entails.

To facilitate this process, we inform you that the Company. REALE Seguros offers a specific product that covers the use / use of golf buggies by users. To request information, you can contact Fernando Garay at 91-309 76 44 or fernando.garay@reale.es

IN CASE OF ACCIDENT of the federated OR DAMAGE caused by the federated (to a third)

1. Accident or damage **must be reported IMMEDIATELY AFTER ITS OCCURRENCE BY THE FEDERATED GOLF CLUB** to the Call Center **902-876 627**.

Abroad, the federated must inform of the occurrence of the incident by fax to 00 + 34 902012491.

2. **Next, THE PART** (accident / damage) **MUST BE FULFILLED, SIGNED, SEALED AND REMITTED BY FAX** (part of accidents: 91-278 8526 - part of damage: 91-218 12 65) to **REALE, BY CLUB / FIELD OF GOLF OR FEDERATED SPORTS INSTALLATION WHERE THE FACT HAS HAD PLACED**. The golf club must also deliver the original of said part to the federated one and MUST OBLIGATORY copy.

It is IMPORTANT that SPECIAL ATTENTION be given to the CORRECT FULFILLMENT of the PART so that:

1. **The injured federated** member can access the medical assistance guaranteed in the policy without any problems (which will be provided by the Medical Center or optional doctor CONCERTADO by REALE Seguros).
2. **The damaged third party** can access without any inconvenience **the coverage of the damages suffered in his person or in his property**, both inside the sports venue and outside it.

For the purpose of preventing possible frauds that increase the policy to the federated and also for statistical reasons, REALE Seguros will carry out a record of the number of processed parties. For this reason it is **COMPULSORY FOR CLUBS / FIELDS OF GOLF AND FEDERATED SPORTS FACILITIES, TO KEEP THE PARTS PROCESSED**, at least during ONE YEAR after the communication thereof to the Company. insurance carrier.
